

In accordance with federal regulations, the ABAC IRB requires **all** responsible researchers, co-investigators, key personnel, including unaffiliated investigators, and faculty advising student researchers to complete the Collaborative Institutional Training Initiative (CITI) educational program.

Co-investigators from other institutions are not required to complete this if they have a certificate of completion from their own federally assured IRB.
