- (2) The Unaffiliated Investigator understands and hereby accepts the responsibility to comply with the standards and requirements stipulated in the above documents and to protect the rights and welfare of human participants in research conducted under this Agreement.
- (3) The Unaffiliated Investigator will comply with all other applicable federal, international, state, and local laws, regulations, and policies that may provide additional protection for human research participants conducted under this Agreement.
- (4) The Unaffiliated Investigator will abide by all determinations of the ABAC Institutional Review Board (IRB) and will accept the final authority and decisions of the ABAC IRB, including, but not limited to, directives to terminate participation in designated research activities.
- (5) The Unaffiliated Investigator will complete educational training required by the ABAC IRB (available at <http://www.citiprogram.org>) prior to initiating any contact or interaction with prospective or planned participants in the research covered under this Agreement.



- (6) The Unaffiliated Investigator will report promptly to the ABAC IRB any proposed changes in the research activities conducted under this Agreement. The Unaffiliated Investigator will not initiate changes in the research protocol without prior ABAC IRB review and approval, except where necessary to eliminate apparent immediate hazards to research participants.
- (7) The Unaffiliated Investigator will report immediately to the ABAC IRB any unanticipated problems involving risks to participants or others in research covered under this Agreement.
- (8) The Unaffiliated Investigator, when responsible for enrolling research participants, will obtain, document, and maintain records of informed consent for each such participant or each participant's legally authorized representative as required under USDHHS regulations at 45 CFR Part 46 and as stipulated by the ABAC IRB.
- (9) The Unaffiliated Investigator acknowledges and agrees to cooperate in ABAC IRB's responsibility for initial and continuing review, record keeping, reporting, and certification for the research referenced above. The Unaffiliated Investigator will provide all information requested by the ABAC IRB in a timely fashion.
- (10) The Unaffiliated Investigator will not enroll participants in research under this Agreement prior to review and final approval of the research protocol by the ABAC IRB.
- (11) Emergency medical care may be delivered without ABAC IRB review and approval to the extent permitted under applicable federal regulations and state law.
- (12) This Agreement does not preclude the Unaffiliated Investigator from taking part in research not covered by this Agreement.
- (13) The Unaffiliated Investigator acknowledges that he/she is primarily responsible for safeguarding the rights and welfare of each research participant, and that the research participant's rights and welfare must take precedence over the goals and requirements of the research.
